21/46 - Uplyme Traffic Management Strategy and Highways

Resolved: that the Council discussed the following:

- (a) Cllr C James provided Members with an update regarding his meeting with Mr D. Ashford (DCC) and Cllr I. Hall (C. Cllr) in respect of local highway issues. This included safety improvements to Lyme Road (Crogg Lane narrow).
There are some concerns with the “line of sight and distances” at the Crogg Lane narrow, but all concerned are positive that this project could come into fruition and be part of a good partnership. It is hoped funding is available from Dorset CC, EDDC, DCC and Uplyme Parish Council through CIL and Section 106.
Cllr I. Hall added that he is mindful that if this project is completed that it does not cause other issues, but does agree that children do need a safe passage to school and he will assist with this project.
- (b) Members noted that it is easy to directly report any defects to Devon County Council / Highways online, the Clerk will also provide residents with details how to report a defect.
