i)	22/2279/VAR	Sunbeams, Rhode Lane, Uplyme Lyme Regis DT7 3TX	Variation of conditions 2 (approved plans) and 9 (tree protection) of planning permission 21/0970/FUL (Erection of a single storey house in garden plot) to allow for removal of tree T1; and variation of conditions 10-14 to change trigger points, reword condition 10 to omit an erroneous reference to an ecological impact assessment, reword condition 11 to omit an erroneous reference to a technical note, amend condition 13 to apply only to the site frontage and amend condition 14 to correct the road name and remove the requirement for elevations and cross-sections.
ii)	23/0383/FUL	Land South Of Little Hill Cottage, Holcombe Lane, Uplyme	Retrospective application for agricultural access track
iii)	23/0376/FUL	The Old Stores, Lyme Road, Uplyme, Devon DT7 3TH	Demolition of side conservatory, grey flat roof building and lean-to former extension. Improvement to drive to increase parking area and the replacement of windows.
