ii)	23/1282/LBC	Allerford, Tappers Knapp, Uplyme, Devon DT7 3TW	Construction of side extension with flue on north elevation. Internal alterations and removal & construction of walls and ceilings on both ground floor, first floor and loft. Blocking window and removing a door on ground floor east facing elevation. Replacing 2no. windows at first floor rear west elevation. Addition of 3no. rooflights on rear west elevation. Replacing main roof clay tiles with slate tiles, and replacing polycarbonate roof on rear west elevation. Increase height of stone wall on front east elevation.
iii)	23/1514/FUL	Brooklands, Lyme Road, Uplyme Devon DT7 3UY	Proposed change of use of part residential curtilage to car parking area for adjacent garage
