Approx 3m reduction of this branch back to approx 1m from the trunk to ensure no longer over the footpath.

iii)	23/1654/FUL	Keepers Cottage St Marys Lane Uplyme Devon DT7 3XH	Add privacy gates for vehicles and pedestrians, and improve drainage on to drive.
