PC23/89 Planning Applications

(a) **RESOLVED** that the following comments be submitted to East Devon District Council:

The safety of trees overhanging this very busy path is the responsibility of the landowner, as well as the security of adjacent properties. The owner of a neighbouring property on the southern side of the Lim Valley Path informed the Parish Tree Warden of the problematic branches, and the site was visited. Whilst the Application

is to reduce ONE branch of a single tree in this river woodland TPO site, closest to the cottage chimney stack, it is not the only branch overhanging the cottage from this and other trees in the hedge. Tree branches also overhang device wires running from an adjacent pole, and further problems could arise. The Applicant makes reference to advice taken from an arborist that indeed further works may be required. This advice is not provided in written document as part of the Application, which the Council believe is a requirement. Whilst the Council support the Application, we request the EDDC Arboricultural Officer to require formal advice on addressing the problematic overhanging of these hedgerow trees. This could then inform and support a revised Application, or indeed a second one. (4-0)

23/1737/FUL

Sunbeams, Rhode Lane, Uplyme DT7

The Parish Council are not in support of this application for the following reasons: a) the size and proportions of the 'dormer' are too large for the size of the existing property. b) the number and size of the proposed glazing for the 'dormer' would overlook the neighbouring property behind Sunbeams, thereby diminishing the neighbours privacy. c) whilst the roofline is not being heightened, the conversion of the loft contravenes the previously refused applications 17/2271/FUL and 20/1473/FUL for a two storey property. d) Approved application 22/2168/FUL already affords the owners of Sunbeams extra accommodation in the form of an annexe.
