23/1004/FUL	Land Adjacent Regis House, Lyme Road, Uplyme Devon DT7 3TJ	The Parish Council does not support this application due to there not being enough proposed parking provision for the site. Other considerations which have not been adequately considered is the effect of the vibrations on the surrounding land from the piling being constructed and pedestrian safety during works. Furthermore, the Council are not convinced that the curtilage outlined on the plans is correct. (3-2)
